

LICENSE AGREEMENT FOR REMCOM'S PRODUCTS

NOTICE: Use of Remcom's API libraries, to include use within products developed by other entities, is governed by the Remcom license agreement contained herein. See the Restrictions Clause for a list of restrictions, and please contact Remcom should you wish to discuss possible arrangements for redistribution or licensing outside of the specific individual or entity for which you have obtained this license.

IMPORTANT-READ CAREFULLY. This Remcom End-User License Agreement ("EULA" or "AGREEMENT") is a legal agreement between you (either as a registered individual user or as the registered user/representative on behalf of a single entity) and Remcom, Inc. for the Remcom software product identified above, which product includes computer software from Remcom and may include computer software from Remcom's licensors, associated media, printed materials, and "online" or electronic documentation ("PRODUCT"). By installing, copying, or otherwise using the PRODUCT, you agree to be bound by all the terms and conditions of this EULA. If you do not agree to all the terms and conditions of this EULA, then DO NOT install or use the PRODUCT; you may, however, return it to your place of purchase for a full refund.

The PRODUCT is protected by copyright laws and international copyright treaties, as well as other intellectual property laws and treaties. The PRODUCT is licensed, not sold.

1. License. REMCOM, Inc. ("REMCOM") grants to you a limited license to install and use the PRODUCT (the "License") on a computer at the site(s) designated in the License Key (defined below), but only if the total number of simultaneous installations of the PRODUCT does not exceed the number permitted by the License Key. This Agreement does not convey any ownership of the software or of any copy of the PRODUCT to you.

REMCOM offers three categories of Licenses to the PRODUCT to end users. You are only authorized to use the PRODUCT pursuant to the type of license purchased from REMCOM and any unauthorized use is strictly prohibited under this EULA. The categories of Licenses offered are as follows:

- a. Node-locked: A customer purchasing a node-locked license may only use the product on one workstation, and the license shall be tied to the MAC address of that workstation. Any reproduction or reverse engineering of the PRODUCT to allow use on additional workstation shall constitute a violation of this EULA.
- b. Hardware Key: A customer purchasing a Hardware Key license may install the PRODUCT on any workstation but may only activate and use the PRODUCT while a REMCOM-provided USB dongle is connected to the particular workstation. Each USB dongle allows for activation and use of the PRODUCT on a single workstation at a given time. Any use of a particular REMCOM-provided USB dongle to activate and use the PRODUCT on more than one workstation at a single time shall constitute a violation of this EULA. Any use of an unauthorized USB dongle to activate and use the PRODUCT shall also constitute a violation of this EULA.
- c. Floating: A customer purchasing a floating license may install the PRODUCT on a network server. Users may check out and use the PRODUCT from authorized workstations that are connected to the server. Customers licensing the PRODUCT under a floating campus license may check out the PRODUCT on any workstation in an agreed-upon ZIP code. Customers licensing the PRODUCT under a floating continental license may check out the PRODUCT on any workstation in an agreed-upon country. Customers licensing the PRODUCT under a floating global license may check out the PRODUCT on any workstation around the world.

Use of a floating license outside of the agreed-upon area shall constitute violation of this EULA. A customer may only check-out and use the PRODUCT on one workstation at a given time per floating license purchased. A customer may not use a single floating license on more than one workstation at a given time, and doing so shall constitute violation of this EULA.

2. License Key. Some or all of the PRODUCT must be activated with a license key obtained from REMCOM (the "License Key"). The License Key may impose restrictions and terms on your use of the PRODUCT, in addition to those contained in this EULA, including: (a) the number of copies you may install and use under the License, (b) the duration of the License, (c) the sites where you may install and use the PRODUCT; and (d) the version of the PRODUCT to which the License applies. You agree to fully comply with these and any other restrictions and terms imposed by the License Key.

3. Restrictions. Except as explicitly permitted in advance by REMCOM in writing, you must not: (a) install any or part of a PRODUCT on a server or other network unless permitted by your License Key; (b) hack, reverse engineer, decompile, disable, disrupt or interfere with the functioning of any of the PRODUCT or License Keys; (c) modify any of the PRODUCT or License Keys, or create a derivative work of any of the PRODUCT or License Keys; (d) use the PRODUCT for any purpose that may be defamatory, threatening, abusive, harmful or invasive of anyone's privacy, or which may violate any law, or may give rise to civil or other liability; (e) allow any third party to use or access any of the PRODUCT or License Keys without our prior written consent; (f) copy, redistribute, encumber, sell, rent, lease, sublicense, or transfer any of the PRODUCT or License Keys to any third party; or (g) permit, assist or allow any third party to do any of the foregoing.

In addition to any other available remedies, REMCOM may terminate the License upon breach of any of the above obligations.

4. Termination. If the License Key limits the duration of the License, then the License will terminate automatically on the termination date included in the License Key. Without prejudice to any of REMCOM's rights at law or equity, REMCOM may also terminate the License immediately if you fail to comply with any of the terms or conditions in this Agreement.

5. Effect of Termination. Upon termination of the License you must: (a) immediately uninstall, stop using, and return to REMCOM the License Key and the software portions of the PRODUCT, and (b) certify in writing to REMCOM, within 10 days from the termination date, that you have complied with the above obligations.

6. Limited Warranty and Disclaimer of Implied Warranties. REMCOM warrants that the PRODUCT will perform substantially in accordance with the specifications set forth in the documentation provided with the PRODUCT, for a period of one year from the date of original delivery to the customer. This warranty will not apply to defects or malfunctions caused by normal wear and tear, or by any alteration, modification or improper repair of the PRODUCT performed by anyone who is not an employee or authorized representative of REMCOM, or by defects or malfunctions caused due to abuse or misuse. This warranty is only to the original licensed end- user. No warranty is made to any other person.

REMCOM does not warrant that the PRODUCT will meet customer's requirements or that the operation of the PRODUCT will be accurate, uninterrupted or error-free. The PRODUCT warranty does not cover any PRODUCT which has been altered or changed in any way by anyone other than REMCOM.

THE WARRANTY SET FORTH ABOVE IS IN LIEU OF ALL OTHER IMPLIED AND EXPRESSED WARRANTIES, WHETHER ORAL OR WRITTEN. REMCOM AND ITS LICENSORS DISCLAIM ALL TERMS, CONDITIONS, GUARANTEES, REPRESENTATIONS AND WARRANTIES (EXPRESSED OR IMPLIED) IN RESPECT OF THE PRODUCT, INCLUDING THOSE OF NON-INFRINGEMENT, TITLE, QUALITY, MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. THE AGENTS, EMPLOYEES, DISTRIBUTORS AND DEALERS OF REMCOM ARE

NOT AUTHORIZED TO MAKE ANY MODIFICATIONS TO THESE WARRANTIES, NOR ADDITIONAL WARRANTIES BINDING ON REMCOM OR ITS LICENSORS.

7. Customer Remedies and Limitations of Liability. During the one year warranty period, if the PRODUCT does not perform as warranted, REMCOM at its sole option will either: (a) provide, without charge, corrected PRODUCT, (b) replace, without charge, PRODUCT with a functionally similar PRODUCT, or (c) refund the fees paid for licensing the PRODUCT. These are your sole and exclusive remedies for any breach of warranty.

RECOM AND ITS LICENSORS SHALL NOT IN ANY CASE BE LIABLE FOR SPECIAL, INCIDENTAL, CONSEQUENTIAL, INDIRECT, OR OTHER DAMAGES ARISING FROM ANY BREACH OF THESE WARRANTIES, BREACH OF CONTRACT, NEGLIGENCE, OR ANY OTHER LEGAL THEORIES, EVEN IF REMCOM OR ITS AGENT OR THEIR LICENSORS HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. IN NO CASE SHALL REMCOM'S OR ITS LICENSORS' LIABILITY EXCEED THE LICENSE FEES PAID BY YOU FOR THE PRODUCT.

8. Copyright and Trademarks/Proprietary Rights. The PRODUCT is the valuable trade secret property of REMCOM and its licensors and all software bearing a copyright notice is, in addition, subject to copyright laws. UNAUTHORIZED COPYING, USE, OR DISCLOSURE OF THE SOFTWARE PRODUCT IS AN INFRINGEMENT OF REMCOM'S AND ITS LICENSORS' COPYRIGHT AND TRADE SECRET RIGHTS. Not by way of limitation of the foregoing, all title, trademarks and copyrights in and pertaining to the PRODUCT (including but not limited to any images, photographs, animation, text, and applets incorporated into the PRODUCT), the accompanying printed materials and any copies of the PRODUCT are owned by REMCOM or its affiliated companies or their licensors. In addition to applicable trade secrets laws as stated above, the PRODUCT is protected by copyright and trademark laws and international treaty provisions. You must treat the SOFTWARE PRODUCT like any other copyrighted work for archival purposes. You may not remove, modify or alter any copyright or trademark notice from any part of the PRODUCT or any License Key, including but not limited to any such notices contained in the physical and/or electronic media or documentation, in the Remcom Setup Wizard dialogue or 'about' boxes, in any of the runtime resources and/or in any web-presence or web-enabled notices, code or other embodiments originally contained in or dynamically or otherwise created by the PRODUCT.

9. Miscellaneous. This agreement will be governed by the laws of the Commonwealth of Pennsylvania, U.S.A. (not including laws relating to choice of law). You and REMCOM consent to the exclusive jurisdiction of and venue in the state and federal courts located in Bellefonte, PA, and/or US District Courts for the Middle District of Pennsylvania, USA in connection with any suit or action brought regarding the PRODUCT or this Agreement. If any legal action is brought by either party against the other regarding the subject matter of this Agreement, the prevailing party shall be entitled to recover, in addition to any other relief, reasonable attorneys' fees and expenses.
